#### **Overview:**

United Way of King County seeks to support child care and early education programs serving children with specialized care and activities to meet individual children's most urgent needs. Investments will help keep young children thriving in care by providing supports designed for those impacted by toxic stress, trauma, and/or special needs.

## Current investments in Quality Child Care (#2209) will end June 30, 2018. Programs interested in child care investments for FY19 must apply to be considered for funding.

Dollars Available: Approximately \$300,000 is available

**Award range:** Grants will be in the \$30,000-\$75,000 range.

**Funding period:** Awards will be made for a one-year period from July 1, 2018 – June 30, 2019.

#### **Goals for Investment**

This funding will help child care and early education providers gain necessary resources to provide culturally responsive specialized supports to low-income children with the most urgent needs. Our goal is to respond to big challenges early and help keep the youngest children and their families thriving in child care.

Specialized supports include any special service adaptations or additional activities that have been created in order to meet the needs of an individual child or family in care. Adaptations or added activities may be temporary or last throughout the time the child and family is in care depending on the specific urgent issue or need.

Examples of specialized supports include-

- Environment & Resources
  - Updates to classroom setting or caregiving environment (i.e. creating a quiet resting corner)
  - Providing specialized equipment or materials (i.e. purchasing added safety equipment)
- Specialized Staff Support Activities
  - Reflective Practice (i.e. staff discuss and reflect on challenging situations in a supportive environment)
  - Technical Assistance or Consultation (i.e. staff work with another professional to problem solve and learn new skills for engaging a child or family)
- <u>Specialized Family Support Activities</u>
  - Engagement with families (i.e. meet with families in person or over the phone during difficult times)
  - Resource referrals (i.e. directly connecting families with resources and providing followup to ensure services are delivered)

#### **Priorities for Investment**

- Reaching low-income children birth to three years of age.
- Specific supports for low-income children and families with urgent needs (including but not limited to families experiencing child welfare involvement, trauma/mental health challenges, behavioral challenges, special needs, homelessness/housing instability etc.).
- Reaching low-income children of color and children from immigrant and refugee families.
- Culturally specific and culturally responsive organizations most equipped to successfully serve families of color. Culturally Specific Organizations are local organizations led and staffed by persons of color that primarily serve communities of color. Culturally responsive services are those that are respectful of, and relevant to, the beliefs, practices, culture and linguistic needs of diverse consumer/client populations and communities.

#### <u>Eligibility</u>

Programs funded through United Way's Early Intervention Investment Area #2409 are not eligible for this funding.

#### **Reporting**

Quarterly progress reports as well as a year-end final report are required, providing detailed summary of support activities completed to date, including narrative descriptions of highlights, successes and challenges encountered and resolved.

#### **Additional Requirements**

Applicants who receive funding will be required to attend United Way of King County early learning grantee meetings.
